Rehearsal & Rehearsal Dinner

TERMS AND CONDITIONS

1. A 50% non-refundable retainer fee is required at time of booking to guarantee our availability on your date. The remaining balance is due 7 days prior to the wedding ceremony. Failure to pay the full balance prior to the event will cancel the booking and forfeit the retainer fee.

2. Retainer fees are not refundable.

3. Any footage to be emphasized or omitted must be expressed to the video crew during time of shooting and in writing within 3 days after ceremony (email is acceptable). Image Street, LLC will exercise best efforts to film and edit the footage as professionally as possible under contracted terms.

4. All videos are subject to be used as a demo and you can be used as a reference.

5. Image Street, LLC makes no guarantees, either expressed or implied, in regard to the aesthetic or stylistic qualities of the completed video.

6. Delivery times vary. Videos normally are delivered within 6-10 weeks following the event.

7. Image Street, LLC uses existing light for all footage. Image Street, LLC will not be responsible for dark video footage due to dim lighting conditions at the location of wedding events.

8. The wedding party, prior to the ceremony, must verify permission to film on location. Image Street, LLC will not be responsible for unwanted shooting angles due to venue rules.

9. Image Street, LLC must be provided, in typed print, all names that will be in the video credits prior to the wedding ceremony. Image Street, LLC is only responsible for the proper spelling of the material given. If the list of names given contains spelling errors, Image Street, LLC will only correct the errors for the editing rate of \$50.00 per ½ hour.

10. Any edits of final product due to error of Image Street, LLC will be done free of charge. Any edits of final product not due to error of Image Street, LLC will be done at a rate of \$50.00 per ½ hour.

11. Edited footage may be reduced such that it is not shown in real time.

12. There is a possibility of camera failure and loss of footage leading to an incomplete video. In case of such failure, Image Street, LLC will use best efforts to edit the video.

13. Image Street, LLC takes utmost care with respect to the exposure, editing, duplication, and delivery of the video products and services offered. However, in the event that either party to this Agreement fails to comply with the terms of this Agreement, liability is limited to the refund of the total value of this Agreement, less the retainer fee.

14. If any provision of this Agreement is held unenforceable, then such provision will be modified to reflect the parties' intention. All remaining provisions of this Agreement shall remain in full force and effect.

15. In the event of litigation relating to the subject matter of this Agreement, the non-prevailing party shall reimburse the prevailing party for all reasonable attorney fees and any resulting costs.

16. Image Street, LLC's principal place of business is in Spring Hill, Tennessee. This agreement shall be interpreted under the laws of the State of Tennessee.
